RELEASE OF LIABILITY

The Retrievers, Inc., a Minnesota non-profit corporation ("RETRIEVERS") and the undersigned person(s) enter into this Release of Liability and Hold Harmless Agreement ("AGREEMENT") on _____. The Agreement considers the risk of injury that a lost dog may sustain from the Lost and Found Dog Search Efforts ("SEARCH") and other related activities.

Inherent Risks of Dog Search Efforts and Other Related Activities

By signing this AGREEMENT, the undersigned acknowledges that he/she is fully aware of the extreme risks, dangers, and conditions that can be an integral part of searching and capturing a lost dog and other related activities including but not limited to:

1. the dangers of property damage, serious bodily injury, and death;
2. the propensity for dogs to behave in ways—such as biting or other aggressive behavior—that may result in death or injury to a person that is around the dogs;
3. the unpredictability of a dog's reaction to things such as sound, sudden movement, unfamiliar objects, persons, or other animals;
4. the dangers of physical injury to the dog; and
5. the natural hazards encountered during a search such as surface or subsurface conditions.

The undersigned also acknowledges that lost dogs are not necessarily trained, can revert to feral behavior, and have an increased propensity for unpredictability, misbehavior, and reactivity to stimuli. The RETRIEVERS do not guarantee the safety of any lost dog.

By signing this agreement, the undersigned acknowledges that he/she has voluntarily chosen to have the RETRIEVERS search for his/her dog thereby assuming all risks associated with the SEARCH and other related activities.

In consideration for having the RETRIEVERS search for the his/her dog, the undersigned agrees to hold harmless the RETRIEVERS and its agents, employees, officers, directors,

representatives, assigns, members, owners, affiliated organizations, insurers, volunteers, and others acting on its behalf (collectively "ASSOCIATES") from all claims, demands, causes of action, and legal liability due to the RETRIEVERS' or its ASSOCIATES' negligence. Furthermore, the undersigned agrees to reimburse the RETRIEVERS for its attorney fees and costs incurred defending any such claim, demand, cause of action, or legal liability released hereunder.

This AGREEMENT is made on behalf of the undersigned who have asked the RETRIEVERS to search for the lost dog and other related activities.
